Many of the animals living at our sanctuaries are unsuitable for rehoming because of their age, medical or behavioural problems. By sponsoring one of these animals you can take an interest in the welfare of an individual animal and contribute towards their quality of life. Our resident animals result in considerable expenditure on vet bills and food costs, typically in excess of £500 per year for each animal. Sponsorship in the form of a donation assists us in providing for these animals which would otherwise be without a home and a donation of £4 per month (less than £1 a week) or more helps to ensure we can properly care for our residents.
